# New Norman and Ann Hoffman Emergency Center opens on Ridgeview's Waconia campus

The Norman and Ann Hoffman Emergency Center renovation and expansion project on Ridgeview's Waconia campus was completed in early October. Due to the COVID-19 pandemic, in lieu of a public event, a private gathering was held in October at which Ridgeview President and CEO Michael Phelps, Emergency Department physicians, and Ridgeview Foundation representatives had an opportunity to thank longtime Foundation supporters and the project's lead benefactors, Norman and Ann Hoffman, from Waconia. With the Hoffmans' lead gift, plus the collective support of the community, Ridgeview Foundation raised \$9 million for the project.

Renovation of the Emergency Department added 10,000 square feet to the existing 10,000-square-foot facility, enhancing patient privacy, services and technology. The \$18.8 million project highlights include:

- all rooms are flexible to accommodate varied populations;
- an Observation Unit for those not requiring transfer to a hospital bed but needing monitoring in a comforting environment;

- a mental health area, where those needing support and solitude can get the help they need;
- new trauma rooms with advanced technology for those most critically injured; and
- an improved design and workflow to streamline care.

With this project, Ridgeview's Cardiac and Pulmonary Rehabilitation department was moved to a new space in the lower level, with a gym, conference room and consult rooms.

"This is one of the most exciting and important improvements we have made to the Waconia campus, enhancing our capacity to provide lifesaving procedures and care for the thousands of patients and families who use our emergency services each year," Phelps said. "We are grateful for the generous support of the Hoffman family and many others to help Ridgeview expand our capacity to provide emergency services, especially during the COVID-19 pandemic, as the former ED space was constructed in 1991. We wouldn't have been able to as effectively care for our patients without this significant addition."

# Compassionate Team Provides New Beginning Ridgeview Hospice gives comfort to Richard Bigaouette

Former farmer and construction worker, Richard Bigaouette of Hamburg, was excited to enjoy retirement. "My wife and I toured the countryside in our car. When we were not driving somewhere, I helped my wife with the flower garden and I mowed and trimmed the lawn," said Richard. "But it grew harder. It was harder to walk to the garage or to the garden. It was harder to mow, harder to breathe and harder to recover."

Richard eventually visited his doctor after extended periods of pain under his heart and experiencing shortness of breath. At the appointment, his oxygen levels were so low that he needed supplemental oxygen immediately or Richard risked being hospitalized.

Richard was diagnosed with end-stage chronic obstructive pulmonary disease (COPD) and respiratory failure. COPD is a group of lung diseases that make it difficult to breathe due to blockages of the airflow.

After five years of living with COPD, Richard realized everyday activities were becoming even more difficult. "I was less active. I avoided being outside because the heat, humidity and the cold can affect my breathing. I was unable to use stairs," said Richard.

In December 2017, Richard moved to The Harbor at Peace Village, an assisted-living community in Norwood Young America, to receive more assistance. In March 2019, Richard entered the Ridgeview Hospice program.

"I had heard hospice was your last resort. You go into hospice and you're dead," said Richard. "It turned out to be a new beginning that saved my life."

Ridgeview Hospice provides Richard care he can't find anywhere else, and he's supported by the entire team. He enjoys many elements of Ridgeview Hospice, including music therapy, massage therapy, and visits with the chaplain and social workers.

"The music can't be beat!" said Richard. "It provides me with relaxation and a spiritual uplifting." He also enjoys massage therapy, saying, "It helps me feel less pain and I feel the calmness coming on. I can feel uptight and just hearing my massage therapist talk to me during our session gives me such a relaxing feeling."

Richard's faith is an important part of his life, which is why he relishes the weekly visits from the Ridgeview Hospice chaplain. "When the chaplain reads to me, it's the highlight of my day," said Richard. "God gave me life and hospice supports me physically, emotionally and spiritually," said Richard.



Richard feels much different as a result of Ridgeview Hospice. "I am more relaxed than I have been in my life," said Richard. "I honestly can't believe you can get this good of care. The team keeps coming and checking on me and offering more help. I trust everyone on the team like they are family."

This is especially meaningful in 2020, as COVID-19 restricted visitor access at The Harbor at Peace Village. As a result, Richard missed visits from his wife of 60 years, Ardene, and his eight children. "The hospice team keeps me uplifted and I would be lonely if they weren't showing up."

"I can let my mind wander and get down, but someone from hospice comes out and we get to talking. Suddenly, it's like I've lit a candle and I'm back on my feet again."


# Socially distanced fun for all during September's successful golf event

# New COVID Call Center Connects the Community to Experts and Resources

Ridgeview has introduced a one-stop COVID-19 Call Center which simplifies everything related to COVID. Since the pandemic began, symptom guidelines, testing instructions and locations, rules for isolating—it all changes with little notice. It's difficult to stay on top of it all.

Now, you can call 952-442-7811 for COVID-19 guidance.

Ridgeview's COVID-19 Call Center is a new, reliable resource to help you. It is staffed Monday through Friday, 8 a.m. - 5 p.m., and callers have access to triage nurses who are knowledgeable about COVID and the most current Minnesota Department of Health (MDH) guidelines.



### Call Ridgeview's COVID Call Center to:

- Discuss your symptoms with a Call Center representative to determine your next steps.
- Learn if you qualify for testing and to schedule an appointment.
- Learn what to do if someone in your household tests positive.
- Inquire about your test results.
- Learn about insurance coverage for testing.
- Locate the closest testing site.
- Connect with other community resources, such as transportation to a testing site.

Labs are working around the clock, seven days a week, to process test results and Ridgeview is sharing results throughout the weekend. If you have a positive result, you will receive a personal call from a nurse so you have an opportunity to have a conversation about next steps. If you have a negative result, you will receive a text message from Ridgeview.

# Ridgeview Announces Nurse Residency Program

Ridgeview is pleased to announce a new training program designed to transition new graduate nurses to the professional nursing environment using a combination of didactic and precepted clinical experiences. Designed and administered by the University of Iowa, this on-line program will aid Ridgeview in providing a welcoming environment to new graduate nurses as they transition from academia to practice.

Critical skills taught in this program are focused on clinical judgement and decision-making. The program strives to enhance new nurses' knowledge, skills and attitudes necessary to continuously improve professional growth.

Newly hired nurses who are eligible (new graduate with less than 1 year experience) will be contacted regarding enrollment.



## Tax Benefits of the CARES Act

The new CARES (Coronavirus Aid, Relief, and Economic Security) Act is designed to help you, businesses and nonprofits facing economic hardship during the coronavirus pandemic.

### THE LAW, EXPLAINED BY A CHARITABLE **PLANNING ATTORNEY**

Here are a few key provisions of the CARES Act that may affect you and your charitable goals:

#### REQUIRED MINIMUM DISTRIBUTIONS SUSPENDED

The new law temporarily suspends the requirements for required minimum distributions (RMD) for the 2020 tax year. This probably comes as a relief to many of you who would have had to withdraw from your retirement accounts. Many of our donors use their RMD to make a gift from their IRA. Despite the RMD suspension, remember that if you are 70½ or older, you can still make a gift from your IRA or name Ridgeview Foundation as a beneficiary.

#### WHY A GIFT FROM YOUR IRA MAY STILL BE A GOOD IDEA

- Your gift will be put to use today, allowing you to see the difference your donation is making.
- You pay no income taxes on the gift. The transfer generates neither taxable income nor a tax deduction, so you benefit even if you do not itemize your deductions.
- Since the gift doesn't count as income, it can reduce your annual income level. This may help lower your Medicare premiums and decrease the amount of Social Security that is subject to tax.

#### **NEW TAX INCENTIVES**

The CARES Act expands charitable giving incentives and allows taxpayers who take the standard deduction to make up to \$300 of charitable contributions to qualified charities this year. You might think that this is a small amount and would not make a difference. But what if all of our donors gave "just" \$300? Such support would have a huge impact on those we serve.

For those who do itemize their deductions, the new law allows for cash contributions to qualified charities such as Ridgeview Foundation to be deducted up to 100% of your adjusted gross income for the 2020 calendar year.
